I DIRECT my Trustees to retain my property at Webster Street Bendigo aforesaid in which I at present reside or such other property which I may acquire and reside in at the date of my death as a home for my said Wife and allow her to use and occupy same during her lifetime -- and I Direct my Trustees to pay out of the income of my estate all -- rates taxes fire insurance premiums and other outgoings in connection therewith and the cost of keeping such property in good order and repair AND upon the death of my said Wife I Direct my Trustees to sell and realize upon such property and the proceeds of such realization -- shall fall into and form part of my residuary Estate as hereinafter mentioned PROVIDED however that should my Wife at any time not desire to reside in my said home I Empower my Trustees to let such home at the best rental obtainable therefor if in their discretion it is -- deemed advisable and the income therefrom shall fall into and form -- part of my residuary estate and follow the destination thereof but -- should my Wife desire such home sold then I Empower my Trustees to -- sell and dispose of same and the net proceeds shall fall into my -- residuary estate I DIRECT my Trustees to sell and dispose of any -- shares held by me at the time of my death and to pay all or any Calls that may be due at my death or made payable before the sale thereof -- and the net proceeds thereof shall fall into and form part of my ---- residuary estate but notwithstanding the direction for sale thereof

THIS IS THE LAST WILL AND TESTAMENT of me HENRY SIDDALL of Webster Street Bendigo in the State of Victoria Investor I APPOINT my Son HARRY SIDDALL and the SANDHURST AND NORTHERN DISTRICT TRUSTEES EXECUTORS AND AGENCY COMPANY LIMITED of View Street Bendigo aforesaid -- (hereinafter called my Trustees) to be Executors and Trustees of this my Will I GIVE DEVISE AND BEQUEATH unto my said Trustees the whole -- of my estate both Real and Personal UPON TRUST after payment of all -- my just debts funeral and testamentary expenses and the Duty both -- State and Federal payable on my estate and which Duties shall be --- deemed to be a debt due and payable by my estate as follows: I GIVE the Pencil Drawing of my late Father, Two Engravings "Playmates" -- and "Schooling" the Drawing "Little Murderer" and also the Picture of "Wood Lane Hall" (Sowerby) Yorkshire England to my Son Harry -- Siddall absolutely I GIVE to my Wife Mary Amelia Siddall all my -- household furniture and household effects for her own use absolutely I DIRECT my Trustees to retain my property at Webster Street Bendigo aforesaid in which I at present reside or such other property which I may acquire and reside in at the date of my death as a home for my said Wife and allow her to use and occupy same during her lifetime -- and I Direct my Trustees to pay out of the income of my estate all -- rates taxes fire insurance premiums and other outgoings in connection therewith and the cost of keeping such property in good order and repair AND upon the death of my said Wife I Direct my Trustees to sell and realize upon such property and the proceeds of such realization -- shall fall into and form part of my residuary Estate as hereinafter mentioned PROVIDED however that should my Wife at any time not desire to reside in my said home I Empower my Trustees to let such home at the best rental obtainable therefor if in their discretion it is --- deemed advisable and the income therefrom shall fall into and form -- part of my residuary estate and follow the destination thereof but -- should my Wife desire such home sold then I Empower my Trustees to -- sell and dispose of same and the net proceeds shall fall into my --- residuary estate I DIRECT my Trustees to sell and dispose of any -- shares held by me at the time of my death and to pay all or any Calls that may be due at my death or made payable before the sale thereof -- and the net proceeds thereof shall fall into and form part of my --- residuary estate but notwithstanding the direction for sale thereof

I Empower my Trustees to retain all or any of such shares for such --- period as they may deem fit notwithstanding that such shares shall not form part of Trustees' investments and in the event of any loss being sustained by my Estate through the retention of any of such shares my Trustees shall be absolutely exonerated and held indemnified for all --- time against any loss sustained to my Estate through the retention of such shares AND as to all the rest residue and remainder of my Estate of whatsoever nature I DIRECT the same shall be got in realized and collected and the proceeds together with all other moneys forming part of my estate shall be invested on such securities as Trustees may lawfully invest Trust Moneys but my Trustees shall have power to continue all or any investments that I may hold at the time of my death should they in their discretion deem it advisable so to do without being responsible for any loss or depreciation And out of the income derives from such investments I Direct my Trustees to pay to my Wife Mary Amelia Siddall the sum of Three Pounds per week during her life and whilst she resides in my home so retained for her as aforesaid but -- should my said Wife not reside in my said home then she shall receive the sum of Four Pounds per week during her lifetime And as to the -- residue of the income arising from my estate after providing for my -- Wife as aforesaid I Direct that the same shall be paid to all my children and my Grandson Charless Siddall Rann in equal shares during the lifetime of my Wife and as to the share of income to which my said -- Grandchild shall be entitled same shall be paid to his Mother Zipporah Rann AND upon the death of my Wife I Direct my Trustees to divide the residuary estate into five equal parts or shares and to pay to each of my children namely Harry Siddall, Clarice Matear, Zipporah Rann, and Illiffe Jackson one of such parts or shares for their own use and benefit absolutely and as to the remaining part or share to pay the same to my Grandson Charles Siddall Rann for his own use and benefit absolutely upon his attaining the age of twenty five years and pending his attaining that age I Direct that the income derived from such share --- shall be paid to his Mother Zipporah Rann absolutely PROVIDED HOWEVER should any of my children predecease me or die during the lifetime of my Wife then in that event the share of such child so dying shall go to the survivors of my children and my said Grandchild in equal shares -- share and share alike And should my said Grandchild predecease me or

my Wife or die before attaining the age of twenty five years then the share in my residuary estate to which he otherwise would have been -- entitled shall be divided equally between all my children who shall - survive me and my Wife share and share alike Should there be any --- moneys owing to me by any of my children in respect of advances made to them by me in my lifetime then I Direct that upon my death all such indebtedness of my children or any of them shall be immediately cancelled and my children shall be absolutely released of all indebtedness to my estate in respect of any advances so made by me to them in my lifetime I FURTHER DIRECT that should any of the Beneficiaries - under this my Will mortgage pledge charge or alienate or attempt to mortgage pledge charge or alienate in any manner his or her share and interest under this my Will then I Direct that he or she shall absolutely forfeit all interest thereunder and such share shall go to the remaining beneficiaries in equal shares And should any Beneficiary - under this my Will or any person in his or her name or on his or her behalf contest or dispute the validity of this my Will or any of the - dispositions herein then I Direct that such one taking such action - shall absolutely forfeit all interest thereunder and the dispositions herein contained in favor of such one shall cease and be void and are hereby revoked accordingly And as to such share and interest so forfeited I Direct the same shall be divided in equal shares amongst the remaining beneficiaries I REVOKE all former Wills and testamentary dispositions heretofore made by me and declare this to be my Last Will and Testament.

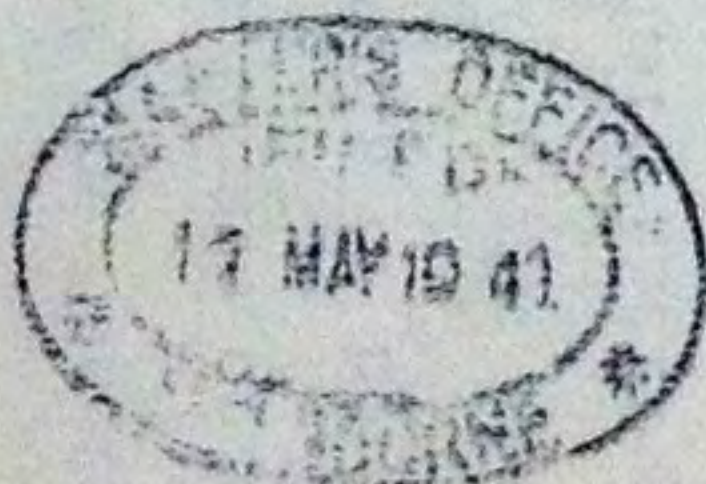
