of this my Will and I GIVE DEVISE AND BEQUEATH the whole of my  
estate and property of whatever kind and wherever situate to them  
absolutely.

3. I DECLARE that in order to assist my Trustees effectively to  
carry out the trusts of this my Will and to administer my estate  
to the best advantage I give them power in their absolute  
discretion and in such manner and upon such terms and conditions  
as they shall think fit and in addition to the rights powers and  
authorities conferred on them by the Trusts Act, 1973 -

- (a) to retain any investment security or property held by me at  
my death and to invest any money in any investments or  
securities of whatever nature and kind whether trustee  
investments or otherwise;
- (b) to sell lease or mortgage all or any part of my real or  
personal estate;
- (c) to appropriate and partition any real or personal property  
forming part of my estate (and for such purposes to  
determine the values thereof) to or towards the share of  
any beneficiary or beneficiaries under this my Will;
- (d) to carry on or join in carrying on any business carried on  
by me at the time of my death either alone or in partnership  
during such period as they shall think fit and for that  
purpose:-

- (i) to retain and invest therein the whole or any part of  
the capital which shall at the time of my death be  
employed therein and employ or advance any additional  
monies and/or assets from time to time out of any other  
portion of my estate with power to do all things as are  
customary in connection with a business of a like  
nature;

- (ii) to introduce at any time or times any other person or  
persons (including any trustee or beneficiary under  
this my Will) as a new partner or partners thereof and  
to arrange and agree as to the division of profits  
thereof or the payment of any sum in lieu of or in  
addition to the profits to any partner;
